

As we begin the Fall 2016 semester, we want to remind you of how the library can enhance your law school experience. Whether you are first joining us as a One-L or you are a returning student, we hope that you will make use of library services. Here are some of the resources we have to offer.

### LEGAL DATABASES

The library gives you subscription access to the following databases:

- Westlaw
- Lexis
- HeinOnline
- CALI
- New York Times Online
- LegalTrac
- MCLE online

### RESEARCH CONSULTATIONS

We are here to help! You may email librarians, stop by the library with questions, or make an appointment for more extensive research. We are happy to show you how to use print materials or online databases to guide your research strategies.

### COMPUTERS AND PRINTING

The library has a printer on every floor. Each semester a print allotment is

allocated to your [UMass Pass](#). Tip: Lexis offers free printing! Pick up your free prints at the circulation desk.

### STUDY SPACE

The library offers space for both group study (first floor) and silent study (lower level and second floor). Private rooms are available on a first come-first served basis. We hope that you will use our white boards and collaborative learning stations.



### STUDY AIDS AND RESERVE BOOKS

The library keeps one copy of each required book behind the circulation desk. These reserve books are convenient when you have forgotten your copy or you need to scan a few pages. They may be checked out for two hours at a time. Study aids are also kept behind the circulation desk and circulate for a period of two hours. Study aids often include outlines, multiple choice

questions, essay questions, and examples and explanations. They will help you prepare for class and exams.



## QUICK RESEARCH TIPS

- Search with “terms and connectors” in Lexis and Westlaw. This will help to tailor your results. For more information check out Westlaw’s search guide: <https://lscontent.westlaw.com/images/content/WLNT&CSearching.pdf>
- Take note of alternative keyword combinations. For example, domestic violence could also be referred to as spousal abuse or intimate partner violence.
- Always follow footnotes to find other useful sources.








## Featured Resource
