LEGAL DATABASES

The library gives you subscription access to the following databases:

- Lexis
- HeinOnline
- CALI
- New York Times Online
- LegalTrac
- MCLE Online

RESEARCH CONSULTATIONS

We are here to help! You may email librarians, stop by the library with questions, or make an appointment for more extensive research. We are happy to show you how to use print materials or online databases to help guide your research.

COMPUTERS AND PRINTING

The library has a printer on every floor. Each semester a print allotment is allocated to your [UMass Pass](#). Tip: Lexis offers free printing! Pick up your free prints at the circulation desk.



STUDY SPACE

The library offers space for both group study (first floor) and silent study (lower level and second floor). Private rooms are available on a first come-first served basis. We hope that you will use our white boards and collaborative learning stations.

STUDY AIDS & RESERVE BOOKS

The library keeps one copy of each required book behind the circulation desk. These reserve books are convenient when you have forgotten your copy or you need to scan a few pages. They may be checked out for two hours at a time. Study aids are also kept behind the circulation desk and circulate for a period of two hours. Study aids often include outlines, multiple choice questions, essay questions, and examples and explanations. They will help you prepare for class and exams.

INTERLIBRARY LOAN

Need a book or article that we do not have in the collection? No problem! Ask a librarian.

FITDESKS

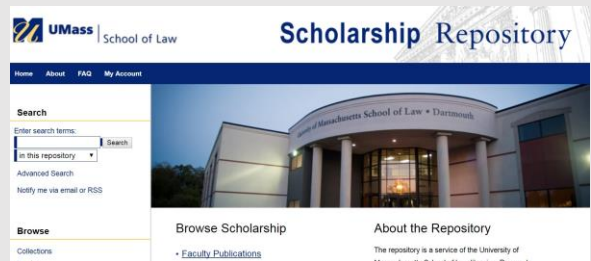

RESEARCH TIPS



Great Places to Start!

- Practice Guides – Breaks down areas of law to give practical instruction to attorneys.
- American Law Reports – Offers entries and citations on unsettled areas of law.
- Trusted Legal Blogs/News – Both Westlaw and Lexis have links to news sources.
- Topical Treatises – These may be found in the databases, in print on our second floor, or we can get almost any book through interlibrary loan.

- Westlaw and Lexis are great resources, but leave no stone unturned! **HeinOnline** offers an extensive library of law review articles. **LegalTrac** has content that may not be available in other databases.
- Try Open Access databases! Social Science Research Network (SSRN) and Digital Commons are freely available online, and include a wealth of articles and scholarly material.
- Always follow footnotes to find other useful sources.

LIBGUIDES

We often design online research guides to specific subjects. For example, we have a guide for Cyber Law and a guide for Trusts and Estates. Please check them out under the “research guides” link on our website. Please let us know what other topics you would like to see in LibGuide format!

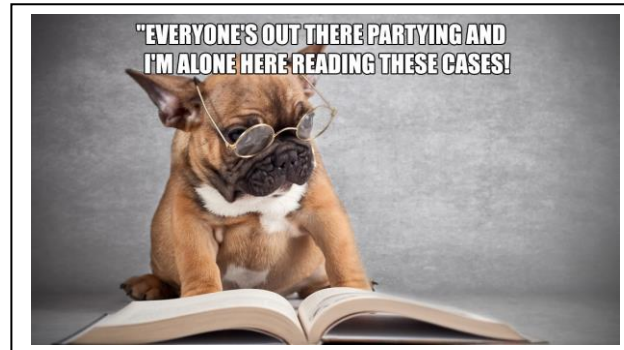
