Featured 1L Resources


Check Out a Guide to Law School



AUDIO DOWNLOADS FOR OFFLINE LISTENING


Download audio lectures from our West Academic online study aid subscription on a variety of topics.

First, get the West Academic Library App, available free in the Apple App or Google Play store.

Sign in to the app with your West Academic username and password. Books and audios you selected for offline viewing using the check box will appear in the app. You can select up to 30 books at a time for offline viewing in either the mobile or desktop apps.

Notes and highlights sync between the online and offline versions of the books.

Access the Law Legends audio series and Sum and Substance series from your computer or phone!



CD sets are available as well. They may be borrowed for one week from the Library Information Desk.
